13 **RUCO'S RESPONSE TO THE COMPANY'S MOTION
14 FOR LIMITED REVISION OF THE PROCEDURAL SCHEDULE**


15 The Residential Utility Consumer Office ("RUCO") hereby responds to the Company's
16 Motion for Limited Revision of the Procedural Schedule. RUCO believes that dividing the
17 issues and setting alternate filing dates for testimony will only result in more work for the
18 parties and additional waste, whereas, the same objective can be reached without the extra
19 effort or waste by simply extending the filing dates. RUCO recommends the filing dates be
20 extended as follows:

21 Rebuttal Testimony by the Company as to all matters would be due on May 2, 2011;
22 Surrebuttal Testimony by Commission Staff and Intervenors as to all matters would be due on
23 May 31, 2011; and Rejoinder Testimony by Goodman Water Company as to all matters would

1 be due on June 10, 2011. The previously scheduled commencement of hearing on June 14,
2 2011 would remain in place.

3 RUCO has been advised by the Company and Staff that they support RUCO's proposal.
4 RUCO has not heard from any of the other intervenors.
