NOTICE OF APPEAL

Pursuant to A.R.S. § 40-254.01 and Rule 5(a), Rules of Procedure for Direct Appeals from Decisions of the Arizona Corporation Commission, notice is given that the Residential Utility Consumer Office, an agency of the State of Arizona, appeals to the Court of Appeals, Division One, from Decision No. 73938 of the Arizona Corporation Commission ("Commission") on June 27, 2013, as affirmed by the Commission on rehearing by Decision No. 74463, entered on April 22, 2014. Appellant, who was an intervenor in the administrative proceeding below, filed an Application for Rehearing of Decision No. 73938 on July 17, 2013, which the Commission granted and held additional hearings on, and which resulted in the Commission's entry of Decision No. 74463. Appellant requests that the Court of Appeals vacate or remand with instructions to the Commission.
